

Having been duly advertised and no protests filed, the County Commissioners approved the transfer of county liquor license no. 3, issued July 1, 1983 to James W. Bridges, Jr. and Marie E. Bridges, dba Elkhorn Bar, to Boyce Distributing Company, Inc. on motion by Commissioner Tomassi. Motion seconded by Commissioner Johnston and passed unanimously.

Michael Cain, member of the Juvenile Planning Committee, introduced Rhonda Griggs as the newly hired coordinator for the Youth Services Project. The commissioners directed the county clerk to advertise a public hearing to transfer \$5544.00, to be received of the State Community Services Division, to fund this budget for the remainder of this fiscal year.

On motion by Commissioner Johnston, seconded by Commissioner Tomassi and carried unanimously, the Board adopted Resolution 84-74B endorsing the application for certification submitted by Western Wyoming Certified Development Company to Small Business Administration.
