RESOLUTION No. 84-85B

WHEREAS, The Board of County Commissioners of the County of Sublette deems the public interest requires the inciting of the procedures under the Industrial Road Program for the Dry Piney County Road No. 23-198:

WHEREAS, The said proposed roadway would commence at the intersection with State Highway 189 in Section 14, T28N, R112W and thence running westerly generally following the existing roadway through said T28N, R112W and T28N, R113W to an intersection with the Big Piney-Calpet County Road No. 23-134 in Section 28, T28N, R113W:

WHEREAS, funding for the County share of this project would come from general County finds augmented by contributions from industrial users and an amount of \$200,000 will be budgeted for this project if the proposal is approved by the Wyoming Highway Commission;

NOW, THEREFORE BE IT RESOLVED, that the said Board be authorized to incite procedures for the Industrial Road Program in accordance with Wyoming Statutes, 1977, as amended, Section 24-5-101, et.seq. for the foregoing named roadway.
