## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming  
September 4, 1984

The Board of County Commissioners met in regular session this date with Commissioners Floyd E. Bousman, Gordon Johnston and Louie Tomassi and County Clerk Lois Yake present.

The meeting was called to order at 9:00 a.m. by Chairman Bousman and the minutes of the previous regular meeting were read. There being no corrections or additions the minutes were accepted and filed as read.

Bid for a new dump truck for the Road & Bridge Department were opened and read aloud as follows:

Commissioner Johnston moved to accept the low bid as submitted by E & L Motors. Commissioner Tomassi abstained from voting. Motion was seconded by Chairman Bousman and carried.

Elvin Booth, Developer of the Jim Bridger Estates, stated that they have completed the roads in the 4th, 5th and 7th filings of the Jim Bridger Estates and asked that the 40 acre tract which the county holds as bond, for completion of the roads, be returned to his firm. It was determined that one small section of road still needs to be constructed and several right-of-way easements need to be obtained before the commissioners relinquish the 40 acres held as bond.

Jim DeBree, District Director for the University of Wyoming, Accompanied by Extension Agents, Stella McKinstry and Eric Peterson, suggested that the Commissioners select several persons as a committee to aid Stella and Eric in programming. He felt that a definite criteria should be developed and used as a guide for selecting this committee. Stella and Eric agreed that this could prove beneficial in developing successful programs and the Commissioners agreed to proceed with the idea when the criteria has been established.

The following Resolution was adopted on motion by Commissioner; seconded by Commissioner Tomassi and carried unanimously.

WHEREAS, the Board of County Commissioners of Sublette County, Wyoming, has determined, after and upon recommendations submitted by the Planning and Zoning Commission of Sublette County, Wyoming, that the Sublette County Subdivision Resolution should be amended, and,

WHEREAS, public hearings have been held on the proposed amendments of the Sublette County Subdivision Resolution before the Sublette County Planning and Zoning Commission on the 19th day of July, 1984, and before the Board of County Commissioners of Sublette County, Wyoming, on the 21st day of August, 1984, in accordance with the provisions of Wyoming Statutes, and,

WHEREAS, the Board of County Commissioners of Sublette County, Wyoming, has reviewed and considered the public comment submitted to the Sublette County Planning and Zoning Commission and to the Board of County Commissioners of Sublette County, Wyoming, pertaining to the proposed amendment of the Sublette County Subdivision Resolution, and,

WHEREAS, the Board of County Commissioners of Sublette County, Wyoming, has determined that the Sublette County Subdivision Resolution should be amended as provided in the amended resolution, a true and correct copy of which is attached to the original of this Resolution, and,
