




OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
Pinedale, Wyoming
November 20, 1984

The Board of County Commissioners met in regular session this date at 9:00 a.m. with Commissioners Floyd E. Bousman, Gordon Johnston and Louie Tomassi and County Clerk Lois J. Yake present.

The minutes of the previous regular meeting were read. There being no alterations or additions the minutes were accepted and filed as read.

The Commissioners executed a Cooperative agreement between the county, Forest Service and White Pine Lodge whereby the county will help provide snow removal to the ski area when necessary. White Pine Lodge will assume liability for damage to the roadway surface, cattleguards, bridges, guardrails and signs incident to the snowplowing done by the county, and the Forest Service will continue to maintain control of the road.

Developer Joe Hicks told the commissioners that he has had culverts installed in the Redstone New Fork River Subdivision as requested and asked that it now be accepted as a county road. Road and Bridge Supervisor questioned whether the size of the culvert installed would be adequate during spring run-off and Mr. Hicks indicated that he would replace it with a larger one if there were any problems. Commissioner Tomassi then moved to accept it as a county road as soon as the resolution can be prepared. Commissioner Johnston seconded the motion. Motion carried.

The Commissioners reviewed a proposed lease agreement between the Sublette County Museum Board and Sublette County Historical Society which allows the Museum Board to use a portion of the Museum of the Mountain Man to display county artifacts in return for payment of the utility bill. The lease will be renegotaited when the Historical Society completes their displays and opens the museum on a permanent basis. Commissioner Tomassi's motion to ratify execution of the lease by the chairman of the Museum Board was seconded by Commissioner Johnston and passed.

Having been advertised in the Pinedale RoundUp on November 15, 1984, hearing was held for the following applications:

1. It was moved by Commissioner Tomassi that the Board accept and act upon the recommendation of the Planning and Zoning Commission and approve the variance application by Larry A. and Jo Ann Doughty to allow Lot 24 of Pine Creek Subdivision to be split into two tracts of approximately .5 acres each. Commissioner Johnston seconded the motion and upon vote the motion was carried and passed.
2. Variance application by Exxon USA, Inc. to allow temporary overhead power lines for the mancamp in Pollywog Subdivision. Cheryl Winkler of Exxon called the Board and said Exxon wished to withdraw the application. A letter will be sent to confirm the phone call.
