

RESOLUTION NO. 84-108B

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF A. L. COOPER AND TELETRACTORS INC. FOR A ZONING DISTRICT BOUNDARY CHANGE FROM A-1 DISTRICT TO I-L DISTRICT FOR .73 ACRES, MORE OR LESS, IN SECTION 33, T34N, R109W, SUBLETTE COUNTY, WYOMING.

A Joint Powers Agreement between the County of Sublette, Town of Big Piney and Town of Marbleton was approved and signed by the commissioners to operate and maintain the Big Piney Airport. The present Big Piney Airport Board will be dissolved according to statute and the name of the Big Piney Airport changed to the Big Piney-Marbleton Airport. The purpose of the agreement is to provide for an efficient, orderly and economical method of managing, operating and maintaining the Big Piney-Marbleton Airport.

On motion fully established the commissioners adopted the following resolution:

RESOLUTION NO. 84-109B

A RESOLUTION FOR ESTABLISHMENT OF A COUNTY COURT SYSTEM FOR SUBLETTE COUNTY, TO BECOME OPERATIONAL AT SUCH TIME WHEN THE COUNTY CAN FINANCE IT, OR WHEN STATE FUNDS BECOME AVAILABLE, WHICHEVER EVENT SHOULD OCCUR FIRST.

Bids for a building to house the fire equipment at Boulder were opened and read aloud as follows: Don Griggs Construction-\$60,625.00 and James Thomas-\$45,852.51. Bids were tabled until the architect could be contacted by telephone. At that time Commissioner Johnston moved that the contract be awarded to low bidder James Thomas. Motion was seconded by Commissioner Tomassi. All voted aye, motion carried.

After discussing Exxon's LaBarge Project with Exxon attorney Ben Hahn and financial advisor Cathryn Rodd the commissioners made application for Certified Carryforward Allocation to Sublette County from the 1984 pool allocation of the state ceiling for private activity bonds in the amount of \$40 million, or the amount remaining in the pool allocation whichever is less and on motion duly established adopted the following resolution for Exxon's LaBarge Project in an amount not to exceed 100 million dollars.

RESOLUTION NO. 84-110B

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF SUBLETTE COUNTY, WYOMING, RELATING TO THE ISSUANCE OF ITS POLLUTION CONTROL REVENUE BONDS (EXXON CORPORATION PROJECT) AND EXECUTION OF A MEMORANDUM OF AGREEMENT RELATING THERETO.

Overcrowding of the jail facilities were discussed with George Blankenship of Denver Research Group; retained by Exxon to study the problem. He indicated that the current problem is not a result of the Exxon LaBarge Project but the increased population generated by the project will also increase the problem and recommended a long-term solution and stated that it should be in place by the spring of 1985 to be effective. A long-term solution appears to be a 14-prisoner facility since the current jail will only allow a one time intergrated expansion and would allow the Sheriff's Department flexibility to safely accommodate women, juvenile, violent and at-risk prisoners with minimal potential for county liability. He was asked to develop some bid specifications to be reviewed by the county attorney prior to advertising for bid proposals in January.
