OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
December 18, 1984

The Board of County Commissioners met in regular session this date with Commissioners Floyd Bousman, Gordon Johnston, Louie Tomassi and County Clerk Lois Yake present.

The meeting was called to order at 9:00 a.m. by Chairman Bousman and minutes of the preceding regular meeting were read. There being no alterations or additions the minutes were accepted and filed as read.

Pinedale Mayor Bill Hout asked the outcome of last week's meeting between the towns, county and D.E.Q. concerning sanitary landfills which he was unable to attend. The commissioners stated that a joint powers board was discussed and it was suggested that the towns would contribute a set amount each year to off-set the cost of staffing the landfills and the county would assume operation and maintenance of the sites. They plan to meet again with the towns on January 8th to work out more of the details.

At the request of Pinedale Town Attorney John Mackey, the commissioners agreed to release a right-of-way easement granted to the county by the town as recorded in Book 22 Miscellaneous Records, Page 37, and accept an easement for a public access road at a new location at the Pinedale Airport due to a land exchange between the town and John Sulenta.

The commissioners reviewed, discussed and rejected a Statement of Claim, received of the Teton County Hospital District, for the care and treatment of patient Lane Raper in the amount of \$10,656.83.

Because the first Tuesday in January is a holiday the regular meeting dates of the Board of County Commissioners have been rescheduled to the second and fourth Tuesdays, January 8th and January 22nd.

Having been advertised in the Pinedale RoundUp on November 15 and December 13, 1984, public hearing was held for the following applications:

- 1. Application withdrawn.
- 2. It was moved by Commissioner Tomassi that the Board accept and act upon the recommendation of the Planning and Zoning Commission. Commissioner Johnston seconded the motion and upon vote it was carried and passed, and the following resolution was adopted:
