

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming
March 19, 1985

The Board of County Commissioners met in regular session with Gordon Johnston, Louie Tomassi and Floyd Bousman, Commissioners and Lois Yake, County Clerk, present.

Chairman Gordon Johnston called the meeting to order at 9:00 a.m. and the minutes of the preceding regular meeting were read. There being no corrections or additions the minutes were accepted and filed as read.

The Commissioners approved and signed an Order for rebate, or reduction of 1984 taxes assessed to 292 taxpayers within the mosquito abatement district.

A hearing on the application for establishment of a private road, filed by Richard B. Dew and Peyton H. Dew, was held at 2:00 p.m. as advertised. Some twenty-five people were in attendance including Attorneys Ken Cohen, representing Richard and Peyton Dew; Hank Phibbs, representing the Carney ownerships; Galen West, representing the Chapman Root Trust and Ed Wood, representing Frank W. Tyler, Jr.

Chairman Johnston opened the hearing and gave a brief summary of the statutes governing the establishment of private roads. He stated that the Commissioners only authority is to determine if the application was filed in compliance with the law and if the road is needed because the applicant is landlocked. If so it is their duty to appoint three disinterested landowners and electors of the county as viewers and appraisers.
