

## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS cont. . . June 18, 1985

WHEREAS, at a regular meeting of the board held on Tuesday, June 18, 1985, the commissioners examined the proposed agreement and unanimously decided and agreed that the sheriff should enter into the same for a one-year period commencing on July 1, 1985, and ending on June 30, 1986, with a proviso allowing the sheriff to assume such duties for the balance of the month of June.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SUBLINTE COUNTY, WYOMING AS FOLLOWS:

1. That the sheriff is authorized and directed to enter into a contract with the Town of Marbleton, Wyoming, to provide it with law enforcement coverage and personnel for the period of July 1, 1985, through June 30, 1986 allowing him to provide such service through the remainder of the month of June under the terms stated.
2. That the board shall approve a budget item of not less than \$100,000.00 in the sheriff's fiscal 1985-1986 budget to allow him to provide such services, and may elect to add thereto to insure proper law enforcement coverage.
