

## RESOLUTION NO. 85-J

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF MELVIN MCLOUGHLIN AND LAVONNE SPENCE FOR A ZONING DISTRICT BOUNDARY CHANGE TO RECLASSIFY AND REZONE FROM A-1 DISTRICT TO R DISTRICT, 24 ACRES, MORE OR LESS, BEING PART OF THE SE/4NW/4 of Section 29, T34N, R109W, SUBLINTE COUNTY, WYOMING.

DISTRICT FOR 8) ACRES, MORE OR LESS, BEING THE S/2NE/4 OF SECTION 12, T33N, R109W, SUBLINTE COUNTY, WYOMING.

11. It was moved by Commissioner Tomassi that the Board deny the variance application by V.L. Looney to allow overhead main utility trunk lines for the proposed Emigration Subdivision being part of Section 10, 11 and 14, T30N, R111W. The application was denied as it did not meet any of the requirements for approval of a variance in the regulations. Bousman seconded the motion and upon vote it was approved.
