Dick Spillman and Taft Barrington of Spillman Data Systems submitted a proposal to exchange the county's Datapoint computer equipment for Wicat system. Mr. Spillman explained that storage on the present system is filled to capacity and needs to be upgraded. The Wicat provides five times more storage, four times more memory and is ten times faster. Under the proposal the original cost of \$42,300.00 for the Datapoint system will be allowed as trade-in leaving a net cost of \$42,459.00 for the Wicat system, plus installation costs of \$7,450.00. The commissioners accepted the proposal to be paid 50% upon installation and the balance in November.
