## RESOLUTION TO PROVIDE INCOME NECESSARY TO FINANCE BUDGET

WHEREAS, on the 16th day of July, 1985, this Board adopted a County Budget for the 1985-86 fiscal year ending June 30, 1986 calling for the following appropriations:
