



OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming  
August 6, 1985

The Board of County Commissioners met in regualr session this date with County Commissioners Gordon Johnston, Louie Tomassi and Floyd Bousman and County Clerk Lois Yake present.

The minutes of the preceding regular meeting were accepted as written on motion by Commissioner Bousman. Motion was seconded by Commissioner Tomassi. Motion carried.

Motion by Commissioner Tomassi, seconded by Commissioner Bousman, voted upon and unanimously carried that upon the county's receipt of a proper easement deed from Jim Bridger Estates, whereby a private road easement is established in favor of all owners and their representatives, heirs, successors and assigns, along the north 60 feet of Lots 21 and 22, Jim Bridger Estates, Fourth Filing, the county will furnish Jim Bridger Estates with a release of its mortgage on 40 acres situated in Section 33, T35N, R113W of the 6th P.M., Sublette County, Wyoming.

Dr. Norman Bell reported the mental health services he has provided within the county during July. He inquired if the Commissioners would consider endorsing an individual as provider of these services to allow disbursement of Sublette County's share of State funding allocated for mental health programs. The Commis-sioners indicated that they are awaiting a reply from the State Department of Social Services concerning their decision not to support Western Wyoming Mental Health and are not prepared to endorse any service provider at this time.

A hearing was held, as advertised, on the application by the First Wyoming Bank, N.A.-Big Piney for the transfer of a county liquor license currently issued in the name of Boyce Distributing Co, dba Elkhorn Bar, Grocery and Gas. Present owner Larry Boyce presented a petition, signed by forty-five Bondurant
