

area residents, stating that the liquor license should remain in the Bondurant valley and petitioning against the removal of the license. Dale Smith, representing the First Wyoming Bank, stated that they do not plan to apply for a transfer of location for the license and that Mr. Boyce will be leasing and operating the business until he can obtain the purchase price or until the property can be sold with approval of the transfer of the liquor license to the purchaser. The County Commissioners also feel that the liquor license should remain in the Bondurant area and indicated that any application to transfer it's location would be denied by them. Commissioner Tomassi then moved to approve the transfer of the liquor license to the First Wyoming Bank, N.A.-Big Piney. The motion was seconded by Commissioner Bousman and carried unanimously.

County Attorney Bill Jackson shared what he had learned at a recent seminar on the Fair Labor Standards Act with the county commissioners, elected officials and department heads. A U.S. Supreme Court decision of April 15, 1985 declared that overtime be recognized and that retroactive compensation be made. Each department is to instruct their employees to submit an itemization of overtime claimed to the County Attorney's office on or before August 19th. The County Commissioners indicated that such overtime will probably be compensated through a flat percentage rate.

Having been published in the Pinedale RoundUp on August 1, 1985, public hearing was held for the following:

It was moved by Commissioner Tomassi that the Board accept and act upon the recommendation of the Planning and Zoning Commission and approve the application for a zoning and development permit by Peter Cameron to locate a gravel pit S $\frac{1}{2}$ SE $\frac{1}{4}$, Section 20, T38N, R113W. Commissioner Bousman seconded the motion and upon vote it was carried and passed.
3. It was moved by Commissioner Bousman that the Board accept and act upon the recommendation of the Planning and Zoning Commission and approve the application of Carl and Peggy Winters to allow overhead power line to Lots 10 & 11, Clark's Acres Subdivision. Commissioner Tomassi seconded the motion and upon vote it was carried and passed.
4. It was moved by Commissioner Tomassi that the Board accept and act upon the recommendation of the Planning and Zoning Commission and approve the application by Exxon Company U.S.A. for a building height variance to allow a peak height of 43 feet for the manifold buildings at the wellsites. Commissioner Bousman seconded the motion and upon vote it was carried and passed.
