## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

Pinedale, Wyoming  
August 20, 1985

The Board of County Commissioners met this date in regular session with Commissioners Gordon Johnston, Louie Tomassi and Floyd Bousman, County Clerk Lois Yake present.

The meeting was called to order at 9:00 a.m. by Chairman Johnston. The minutes of the preceding regular meeting were accepted on motion by Commissioner Bousman, seconded by Commissioner Tomassi and carried.

The Official Bond of Cindy Allen as Clerk/Treasurer of the Town of Pinedale, in the amount of \$50,000.00 was approved and filed with the County Treasurer.

Steve Zimmerman, Administrator of the Division of Community Program for the State, met with the Commissioners to discuss the mental health program in Sublette County. He said that the Southwestern Wyoming Alcoholism Rehabilitation Association is willing to provide these services and urged the Commissioners to meet with Dr. Andy Turner, Executive Director of the Western Wyoming Mental Health Center in an effort to agree on an acceptable individual or agency to receive state funding and make these services available to Sublette County residents.

Larry Rowan and Lorenzo Driggs, of Southwestern Wyoming Alcoholism Rehabilitation Association, also attended the meeting to advise the commissioners that they are willing to provide mental health services in the county if they receive the commissioners endorsement. The commissioners will make a decision after meeting with Dr. Turner on September 3rd.

Courtney Davis, Chairman of the Hospital Board, told the commissioners that Dr. Close, Director of the Marbleton/Big Piney Clinic, has proposed negation of the three year contract with Lander Valley Regional Medical Center of Fremont County as the operator of the clinic in favor of contracting with Westworld Healthcare Resources of California. Rick Anderson, spokesman for Lander Valley, stated that they are not interested in forfeiting the remainder of their contract but will abide with the Commissioners decision. He discussed a list of requests received last week from Dr. Close including the need for expanded hours, an x-ray and lab technician, personnel scheduling and a computer. Mr. Anderson stated that most of the requests were valid and would be met by Lander Valley. Dr. Close has also asked for a full-time clinic director due to the increased patient demands caused by impact from the Exxon Project, but Mr. Anderson indicated that Lander Valley can fulfill its responsibilities without hiring a full-time manager. Mr. Davis told the commissioners that the Hospital Board does not feel that Lander Valley has violated its contract with the county. The Commissioners agreed and endorsed the Hospital Board's recommendation to retain Lander Valley as operator of the clinic.

A Hearing on the Petition of "the Hoback Ranches Property Owners Improvement and Service District" was held at 3:00 P.M. as advertised. Present: Commissioners Johnston and Bousman, Hoback Ranches developer Doyle
