- 3. Application for a zoning and development permit by David C. Favazzo to build a 6-unit apartment in an existing building utilizing Lot 7 and 8 of Favazzo Subdivision Number Two.. Commissioner Bousman moved that the Board accept the recommendation of the Planning and Zoning Commission and deny this application because the apartment complex does not comply with the character of the surrounding area. Commissioner Tomassi seconded the motion and upon vote the motion was carried and passed.
- 4. It was moved by Commissioner Bousman that the Board accept and act upon the recommendation of the Planning and Zoning Commission. Commissioner Tomassi seconded the motion and upon vote it was carried and passed and the following resolution adopted.

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION JOHN C. FRAZIER AND CURT THOMPSON FOR A ZONING DISTRICT BOUNDARY CHANGE TO RECLASSIFY AND REZONE 93 ACRES, MORE OR LESS, FROM A-1 TO R-R 5 BEING PART OF SECTION 25, T37N, R110W, SUBLETTE COUNTY, WYOMING.

- 5. Application for a zoning district boundary change by Howard M. Knutson and Thomas A. Gilbertson to reclassify and rezone 260 acres, more or less, from agricultural (A-1) to rural residential (R-R) being the SW¼NW¼, NW¼SW¼, N½N½SW¼SW¼, SE¼NE¼SW¼SW¼, Section 11 and S½NE¼, N½SE¼, NE¼NW¼SE¼SE¼, N½NE¼SE¼SE¼ of Section 10, T29N, R112W. Planning and Aoning recommended denial of this application. Discussion ensued on the application. Bousman moved that the application be tabled until the Board can meet with the Planning and Zoning Commission to discuss the matter with all the commission members. Tomassi seconded the motion. Motion carried.

County Surveyor Paul Scherbel submitted to the Board the report of the viewers for the proposed establishment of the New Fork Lake Road as an industrial road project to receive the benefits of the industrial road program. The Board approved a letter to be sent to Alfred DeBernardi, district engineer, requesting that the Wyoming Highway Department determine a final center-line survey for the proposed road. A letter to Reid Jackson, Bridger-Teton Forest, stating the status of said road was approved. It was noted that the appointment of Gordon Johnston as a viewer for the New Fork Lake Road was omitted from the August 20 county commissioner minutes. Bousman moved that the minutes of the August 20, 1985, county commissioner meeting be amended to show that Gordon Johnston had been appointed a viewer for the New Fork Lake Road project. Tomassi seconded the motion. Motion carried.
