

RESOLUTION NO. 85-53J

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION BY EXXON COMPANY U.S.A. FOR A ZONING DISTRICT BOUNDARY CHANGE FROM A-1 DISTRICT TO I-H DISTRICT, FOR 160 ACRES, BEING THE NE $\frac{1}{4}$ SECTION 35, T28N, R114W, SUBLETTE COUNTY, WYOMING.
