

## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

January 21, 1986

The Sublette County Board of Commissioners met in regular session this date with members Gordon Johnston, Louie Tomassi and Floyd Bousman and County Clerk Lois Yake present

The meeting was called to order by Chairman Johnston and the minutes of the preceding regular meeting were read. There being no additions or alterations, the minutes were accepted as written on motion by Commissioner Bousman, seconded by Commissioner Tomassi and carried.

A petition on behalf of Richard F. Gordon for a reduction of his 1985 taxes was approved by the Commissioners in the amount of \$124.53.

The Board reviewed the report and recommendations of Jim Noble, the appointed road viewer for three road petitions requesting dedications of existing roads into the county road system as follows:

From Agate Street, on the south boundary of the Town of Pinedale, to Granite Lane between the Rocky Roads and Scenic View Subdivision - Mr. Noble recommended that it be accepted as a county road upon receipt of the required easement and that it should be looked at next spring to determine if more gravel is necessary to bring it up to county standards and if so this should be the responsibility of the developer.
