Sublette County Fair Board - Deanne Bradley: re-appointed to a 5 year term

The Board approved a Tax Reduction Order on 1985 taxes for George R. and Ann A. Brown in the amount of \$47.03.

The County Commissioners signed a Proclamation declaring March 2nd through March 8th, 1986 as DRUG AND ALCOHOL AWARENESS WEEK in Sublette County.

Daniel residents Maggie Hermansen and Barbara Bain asked the commissioners how they would go about getting a fire truck and establishing a volunteer fire department for the Daniel community. The commissioners advised them to first determine if there are enough dedicated people who would be available at all time to man the fire truck and to locate a heated building to store the truck. Mrs. Hermansen stated that Rookies Lodge has offered a heated building at night but it would not be available during the day. Commissioner Tomassi suggested the building at the Daniel Sanitary Landfill until they can find a permanent location. They were also advised to incorporate as a non-profit organization to qualify for county funding. Mrs. Hermansen and Mrs. Bain stated that they will determine if there is enough community interest in the project before proceeding further.
