




The Board of County Commissioners met in regular session this date with members Gordon Johnston, Louie Tomassi, and Floyd Bousman and County Clerk Lois J. Yake present.

The meeting was called to order at 9:00 a.m. by Chairman Johnston. The minutes of the preceding meeting were accepted as written on motion by Commissioner Tomassi, seconded by Commissioner Bousman and carried.

Tom Eno, Pinedale Mental Health counselor and Father Fred Wendel, member of the board of directors visited with the commissioners about the future of mental health in Sublette County. Father Fred stated that the present tri-county program will probably be changed to individual county programs for the next fiscal year. and they are looking at what mental health can mean to Sublette County and gathering facts and figures for presentation to the county commissioners during budget session.

The proposed purchase of a crusher plant was discussed at 10:00 am as scheduled. All bids were reviewed by the commissioners during the past week and those selected for final consideration were Plateau Supply Co. represented by Greg Hymas and Wilson Equipment Co. represented by John Christianson. Also present: Dan Schmidt, Schmidt Dirt Contractors, LaBarge; Lew Clark, Clark's Ready Mix, Jackson, and Joe Simo, Sulenta Construction Co., Pinedale. Chairman Johnston state that that the county has decided to adopt a systematic method of upgrading county roads. The number of miles to be upgraded each year will depend on the cost per mile. Recent estimates for crusted materials have been as high as \$4.50 per ton which would be cost prohibitive and helped convince the commissioners to consider the purchase of the crusher plant.

Chairman Johnston the proposed that the county select a certain number of miles on a specified county road and allow the contractors to bid the materials. If the bids prove reasonable: let a contract, if not, reject the bids and proceed with the purpose of a crusher plant.

After further discussion Chairman Johnston state that he would entertain a motion to reject all bids for the crusher and to select a piece of county road to be upgraded and to request bids for the crushed materials from individual contractors. Commissioner Bousman so moved. Commissioner Tomassi declined to second the motion. Motion Seconded by Chairman Johnston and carried. It was tentatively agreed to request bids for nine miles of the Dry Piney County Road.
