OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

April 15, 1986

The Board of County Commissioners met in regular session this date with members Gordon Johnston and Floyd Bousman and County Clerk Lois Yake present. Absent; member Louie Tomassi.

The meeting was called to order by Chairman Johnston at 9:00 a.m. Minutes of the preceding regular meeting were read. There being no alterations or additions the minutes were accepted on motion by Commissioner Bousman, seconded by Chairman Johnston, and carried.

Barbara Bain asked that their road now be opened following its winter closure. Chairman Johnston recommended that it be opened on the south exposure, from merna to the top of the hill, and possibly further depending on the snow depth on the north side of the hill.

Gregg Anderson, member of the Daniel Voluteer Fire Department stated that they have received their incorporation papers from the state, have elected officer and are meeting twice a month. They have acquired some smaller pieces of fire equipment and are investigating the possibility of obtaining a fire truck through the State Forestry Service which has one large 6x6 fully equipped truck available at the present time which would cost between \$12,000. and \$15,000. Joel Dustin has offered them the use of a garage in Daniel which could be insulated and heated for their initial fire barn. He stated that they are investigating the possiblity of receiving land presently owned by the Pinedale School District or through a possible donation for locating a future fire hall. He said the members are receiving fire training to become certified and that they will be submitting a budget for FY '87 funding through the county.

On motion by Floyd Bousman, seconded by Gordon Johnston and carried, Ron Wilson of Pinedale was appointed to fulfill an unexpired term on the Sublette County Recreation Board.

Dick Tanner of Big Piney was appointed as Sublette County's representative to serve on the Southwest Wyoming Utility User's Association organized to investigate utility rates and to provide testimony on behalf of citizens before the Public Service Commission during Utah Power & Light Company's rate increase hearings.

Road and Bridge supervisor Mike McGinnis reported a recent severe slide on the Jack Creek county road near Bondurant which has the potential of damming the creek if it continues. Mike Matozevich of the local forest service office was present and made arrangements for an engineer and hydrologist to inspect the site on Wednesday to help determine the best method of solving this annual problem.
