



OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS May 20, 1986

The Board of county Commissioners met in regular session this date with members Gordon Johnston, Louie Tomassi and Floyd Bousman and County Clerk Lois Yake present.

Chairman Johnston called the meeting to order at 9:00 a.m. The minutes of the preceding regular meeting were accepted and filed as written on motion by Commissioner Bousman, seconded by Commissioner Tomassi and carried.

The Official Oath and Bond of Betty Lou McLoughlin, as Treasurer of the Upper Green River Cemetery District, in the amount of \$1,000. was approved and filed with the County Treasurer.

Bob Harrower presented a Road Petition asking the county to supply some gravel on that portion of Fremont Ave. located in the Cooley Sixth Subdivision and extending beyond the limits of the Town of Pinedale. The Commissioners explained that the county can maintain only duly established county roads and Ed Adams was appointed to act as the Road Viewer for this petition.

Sealed bids for providing an emergency generator and constructing a building to house the generator were opened and read aloud as follows: Roadrunner Electric, \$31,291.00 and Wyoming Electric Inc., \$35,590.50. On motion by Commissioner Tomassi, seconded by Commissioner Bousman and carried, the low bid submitted by Roadrunner Electric was accepted.

Jim McKee having received a two year honor scholarship has relinquished the County Commissioner Scholarship awarded to him on May 6th. The County Commissioners selected Pat Jensen as the alternate recipient of this one year tuition-free scholarship.

A group of county liquor and malt beverage licensees were present to protest the increase in license fees as adopted by the County Commissioners on May 6, 1986. They felt that the increase of 60% for liquor licenses and 140% for malt beverage permits was excessive in view of the present economy and increased county and excise taxes. And also that the additional \$5,100. would not make that much difference in the county's income but could make a significant difference to small businesses. County license fees were last increased in 1980 by 25%. After further discussion Commissioner Tomassi's motion to rescind the adoption of the May 6th motion for fee increase was seconded by Commissioner Bousman. All voted aye. Motion carried.

The following resolution was adopted on motion duly established:

RESOLUTION NO. 86-78J

WHEREAS, Section 18-3-107, Wyoming Statutes, 1977, amended by Session Laws of 1981, provides that the county Commissioners of each County in the State of Wyoming shall meet not later than June 1, 1978, and on or before the same date each four (4) years thereafter, for the purpose of setting the salaries for County Assessor, County and Prosecuting Attorney, County Clerk, Clerk of District Court, County Sheriff and County Treasurer; and

WHEREAS, said Section 18-3-107, Wyoming Statutes, 1977, also provides that the Board of County Commissioners shall meet not later than June 1, 1978, and on or before the same date each four (4) years thereafter for the purpose of setting their salaries for the following four (4) years commencing January 1; and

WHEREAS, having been duly deliberated and discussed the various factors which are determinative of said salaries and said salaries having been approved by the Board of County Commissioners it is the desire of the Board of County Commissioners of Sublette County, Wyoming, to now set said salaries by Resolution.

NOW, THEREFORE, BE IT RESOLVED, that the County Assessor, County Clerk, Clerk of District Court, County Sheriff and County Treasurer of Sublette County, Wyoming, shall receive an annual salary of \$29,500.00 for the ensuing four-year term commencing January 5, 1987 and ending January 1, 1991. In addition to said monetary compensation, the said elected officer of Sublette County, Wyoming shall receive the same benefits accorded to other full-time employees of Sublette County, Wyoming.

BE IT FURTHER RESOLVED, that the salary for the County and Prosecuting Attorney shall be reduced from the present amount of \$45,000.00, the maximum allowed by Statute, to \$40,000.00 for each year of the four-year term commencing January 5, 1987.
