

The Board of County Commissioners met in regular session this date at 9:00 a.m. Present: Chairman Gordon Johnston, Members Louie Tomassi and Floyd Bousman and County Clerk Lois Yake.

The official Bond of Jane Warinner as Treasurer of the Sublette County Museum Board in the amount of \$1,500. was approved and filed with the County Treasurer.

The Board accepted three Road Petitions requesting the establishment of Meadow Lark Drive and Bob O Link Lane, from the intersection of Meadow Lark Lane southerly Blair Road to the intersection with Antelope Lane, thence westerly along Antelope Lane to the intersection with Meadow Lark Lane and from the intersection of Meadow Lark Lane and U.S. 191 thence northwesterly, easterly and northerly through Big Country Ranches Third Filing and Prospector Square Subdivision as county roads. Ed Adams was appointed as Road Viewer for these petitions.

Barney Snyder also presented Road Petitions requesting establishment of county roads in the Highland View Estates Subdivision described as follows: commencing at the intersection of Stock Driveway and County Road 23-121 northerly along Stock Driveway and terminating at the intersection of Stock Driveway and Sled Runner Road; and commencing at the intersection of Sled Runner Road and County Road 23-121 thence northerly along Sled Runner Road to the intersection of Sled Runner road and Stock Driveway. A Road Viewer will be appointed to view and make a recommendation to the County Commissioners.
