

RESOLUTION NO. 86-97J

WHEREAS, in Lot 4 (NW¼NW¼) of Section 2, T33N, R111W, Sublette County, Wyoming there have been numerous tracts of land created many of which are indefinite in boundaries or which have resulted in hiatuses and encroachments making ownerships confusing and hindering the normal processes of land ownership including assessments for tax purposes; and

WHEREAS, the majority of the land-owners in this area have petitioned the Board of County Commissioners for assistance in resolving the difficulties being experienced; and

WHEREAS, Wyoming Statutes, 1977, as amended, Section 34-12-114 provides for a method for accomplishing a survey and platting of similar areas through an order of the County Clerk with the costs to be assessed upon the tax rolls; and

WHEREAS, the petition of the land-owners requested that this methodology be evoked to accomplish the surveying and platting needed; and

WHEREAS, the County Surveyor stated that it would not cost more than \$500 per tract to accomplish the objectives desired; and

WHEREAS, it appears the cost to be assessed to each tract owner could be paid in installments over a five (5) year period; and

WHEREAS, it appears to be in the interest of the County of Sublette that these problems be resolved amicably as requested by the petitioners;

NOW, THEREFORE BE IT RESOLVED, that the County of Sublette--Board of County Commissioners request that the County Clerk invoke the provisions of said Section 34-12-114 to accomplish the needs of the land-owners; and

FURTHER that the County Surveyor be directed to pursue the matter to a successful conclusion.
