




OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS January 6, 1987

The Board of County Commissioners met in regular session on this date at 9:00 a.m. Present were County Commissioners Floyd Bousman, Louie Tomassi and Monte Skinner; former commissioner Gordon Johnston; Hospital Board Member Pat Jackson; Ric Samulski of the Pinedale Roundup; and County Zoning Administrator Janet Montgomery.

Bousman nominated Louie Tomassi to be Chairman of the Board. Skinner seconded the nominations. The nominations were closed and upon vote Tomassi was elected chairman. Tomassi asked that it be noted in the minutes that if he should be absent at a meeting Bousman should act as chairman.

Bousman moved that the minutes of the December 16, 1986, meeting be approved as published. Skinner seconded the motion. Motion carried.

Tomassi read a letter from the Big Piney Sno-Flies requesting a malt liquor permit for January 25, 1987, for the ice drag race at either Greenwood Reservoir or McNinch Reservoir. Bousman moved that the permit be issued. Skinner seconded the motion. Motion carried.

Tomassi read another letter from the Big Piney Sno-Flies inquiring about funding from the county Recreation Board. The commissioners asked that the county clerk inquire as to what snow machine registration fee funds are available.

Bill Hout, Pinedale Mayor, expressed his concern that East Valley Road is not being plowed. He stated that the town would cooperate with the county.

Hout also submitted a letter from the town endorsing Charles McCarty's reappointment to the Pinedale Airport Board. Bousman moved that McCarty be reappointed to the Pinedale Airport Board. Skinner seconded the motion. Motion carried. Skinner moved that Gary Espencheid be reappointed the the Fair Board. Bousman seconded the motion. Motion carried.

Monte Skinner submitted a letter endorsing the Game and Fish Department proposal to increase the number non-resident elk licenses issued. The Board discussed the benefits to the local economy and increased funding for the winter feeding program. Bousman moved that the Board send letters of endorsement to the Wyoming Game and Fish Dept. and Douglas M. Crowe. Tomassi seconded the motion. Motion carried. Skinner abstained from voting.

Gordon Johnston, Pat Jackson and Bob Dew met with the Board to discuss bill from John Frullo for architectural fees for proposed ambulance building in Pinedale. Tomassi stated that he offered Frullo 50% of his fee now and the balance when the project is completed. Frullo wants \$4,000 now. Tomassi told him to submit a letter to the Board. The commissioners will then discuss it with the Hospital Board. It was decided that a special meeting be held Tuesday, January 13, 1987, at 1:00 p.m. with the present hospital board and newly elected rural health district board.

Stella McKinstry requested that a new conference table be purchased for the extension office. Request tabled.

Bert Reinow told the commissioners he had received a complaint about garbage behind the courthouse. Bob Boyce will be contacted regarding placing a dumpster behind the courthouse.

Laurie Latta asked the commissioners for a resolution endorsing KAO Internaional Inc. and her application to the Economic and Stablization Board for a planning grant to promote international tourism in Wyoming beyond the national parks. Bousman moved that the Board endorse KAO International Inc. and Laurie Latta's efforts to promote international tourism in Wyoming. Skinner seconded the motion. Motion carried.

County Assessor Hazel Werner asked the Board if PAC, Professional Appraisal Company Inc., could use space in the courthouse for the informal assessment hearings by their firm the first week of February. Board said their room would be available all that week except Tuesday.

Judy Bogel submitted a copy of the community service block grant monthly report for the Pinedale Preschool.

John Crow met with the Board. The board determined that the county would continue to pay Crow's benefits
