The Board of County Commissioners met in special session on this date at 1:00 p.m. as advertised. Present were County Commissioners Louie Tomassi, Floyd Bousman, and Monte Skinner; Sublette County Memorial Hospital Board members Courtney Davis and Donnie Pope; Rural Health Care District Trustees Barbara Pape, Bob Dew, Lois Koch, Bill Cramer, and Pat Jackson; Dr. Jeff Stieglitz, operator of the Marbleton/Big Piney Clinic; Marilyn Jensen, Hospital Board secretary; Ric Samulski, Pinedale Roundup; John Crow, County Attorney; John Frullo and Mary Lankford, County Clerk.

Board of County Commissioners Chairman, Louie Tomassi, administered the oath of office to the new Rural Health Care District Trustees Bill Cramer, Pat Jackson, Barbara Pape, Lois Koch, and Bob Dew.

Dr. Stieglitz discussed the background situation at the clinic and his concerns for the needs of the community and maintaining the present employees. The clinic has only generated \$11,000 since October and there presently exists approximately \$20,000 in accounts receivable. Dr. Stieglitz is presently paid \$27,000 per month. It was suggested that a Physician's Assistant be hired which would save \$10,000 per month and reduce costs by 15% for overtime. The Physician's Assistant's supervision was discussed and Dr. Stieglitz commented that would provide the supervision on a weekly basis, depending on who is hired.
