It was moved by Commissioner Skinner and seconded by Commissioner Bousman to support the video-cassette collection. The motion carried.

In accordance with the agenda published in the Pinedale Roundup on December 31, 1986, public hearing was held for the following:

- 1. Commissioner Skinner moved that the Board accept the recommendation of the Planning and Zoning Commission and approve the final plat for Aspen Grove Subdivision. Commissioner Bousman seconded the motion. Upon vote the motion carried.
- 2. Dick Noble informed the Board that the required easement had not been obtained and the Board tabled the request until said easement is obtained.
- 3. Commissioner Bousman moved that the Board accept and act upon the recommendation of the Planning and Zoning Commission. Commissioner Skinner seconded the motion. Upon vote the motion carried and the following resolution was adopted.

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISISON AND APPROVING THE APPLICATION BY VVG PARTNERSHIP AND BOULDER LAKE COUNTRY ESTATES INC. FOR A ZONING DISTRICT BOUNDARY CHANGE TO RECLASSIFY AND REZONE 4.0 ACRES, MORE OR LESS, FROM R-R DISTRICT TO RS-1 DISTRICT BEING LOTS A38, A39, A40, AND A41, BOULDER LAKE COUNTRY ESTATES SUBDIVISION FOURTH FILING, SUBLETTE COUNTY, WYOMING.

Ric Samulski representing the Recreation Board, submitted a petition by the Pinedale Golf Club for a re-tailclub liquor license for the golf course. It was moved by Commissioner Skinner and seconded by Commissioner Bousman to advertise the application for public hearing. The motion carried. It was moved by Commissioner Skinner and seconded by Commissioner Bousman to set the application fee at \$100. The motion carried.

Paul Hagenstein discussed with the Board the water rights belonging to the County Shop property and urged the Board not to abandon the water rights. It was moved by Commissioner Bousman and seconded by Commissioner Skinner to pay the assessment submitted.

The Commissioners directed Paul Scherbel, County Surveyor to obtain the easements and move forward the establishment of the Mocroft Road as a County Road.

Dick Noble and Tom Eno presented the Counseling Service's quarterly report. It was reported that Mr. Zimmerman from the State Office will be making his regular evaluation visit on February 5th. Noble inquired if the Counseling Service could move from its present location to relieve difficulties in the office. The Board approved the move.

Jim and Margaret Noble discussed their right-of-way easement on the New Fork Lake Road concerning utility easements. Nobles requested that the easement stipulate that all utilities be underground. The Board agreed. The easement will be prepared to include underground utilities.

Hazel Werner, County Assessor, discussed the upcoming PAC informal hearings to be held the week of February 2nd.

Nylla Kunard, County Treasurer, discussed with the Commissioners properties with tax liens and what procedure they would like to pursue. Kunard was kiredted to proceed with disposing of the property for satisfaction of the taxes.

The Board of County Commissioners directed the County Clerk to notify the County Department Heads and elected officials of allotting time on the third Tuesday of each month, in the afternoon, to discuss any problems or concerns.
