

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Floyd Bousman, Monte Skinner, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of May 19, 1987, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Skinner. Motion carried.

Sealed bids for a backhoe trailer for the Road and Bridge Department were opened and read. Bids were received from Rock Springs Machine Shop, S & S Machinery, and Wyoming Machinery. It was moved by Commissioner Skinner and seconded by Commissioner Bousman to award the bid in the amount of \$10,626 to S & S Machinery. The motion carried.

Floyd Gordon of the Bridger-Teton National Forest, Pinedale Ranger Station introduced himself to the Board.

Sealed bids for the annual County audit were opened and read. Bids were received from Mariano & Brough, John Mortenson, and Heyborne, Radakovich & Costantino. It was moved by Commissioner Skinner and seconded by Commissioner Bousman to award the bid in the amount of \$8,500 to Mariano & Brough. The motion carried.

Mike McGinnis, Road & Bridge Foreman, reported that gravel for the Horse Creek Road could be purchased from Bill Koch at \$.50 per yard and directed to purchase the gravel. McGinnis reported that Reed's Ready Mix would trade chip rock for larger gravel, load for load, and directed to perform the trade. Possible fabric material was discussed for use on the Horse Creek Road, but no prices were available at this time.

Lee Wollrab, representing the Wyoming Game and Fish, and Dave Harper, representing the BLM, discussed the concerns for the antelope habitat at the Big Piney Landfill site and the possible expansion of the site for use by Teton County. Wollrab informed the Board that 400-600 antelope use that area for winter range and discussed the economic impact of the herd. The Board expressed their concern about developing additional sites since they have eliminated the Boulder and Daniel sites and the overall impact on wildlife in Sublette and Teton Counties. Wollrab indicated that the Game and Fish would be unable to support the proposed expansion at the Big Piney site.

Amy Reed, representing SWARA, presented her budget request and was informed that the County intends to continue to provide SWARA office space, but indicated that no funding will be available for social services unless unanticipated revenue is received.

Vern Gildea and Gene and Stella Taylor discussed with the Board the condition of the Horse Creek Road and were informed that the Board and Mike McGinnis were collecting information and prices on materials to repair the road.

Friday, July 3 was designated as an official County holiday.

In accordance with the agenda published in the Pinedale Roundup on May 28, 1987, public hearing was held for the following:

1. Conditional use application by School District No. 1 to build a new school at Bondurant in the SE1/4SE1/4, Section 4, T37N, R113W. It was moved by Commissioner Skinner and seconded by Commissioner Bousman to accept the recommendation of the Planning and Zoning Commission and approve the conditional use permit for School District No. 1. The motion carried.
2. Variance application by Utah Power and Light to cross Lot 9, Redstone New Fork River Subdivision with overhead transmission power line. It was moved by Commissioner Bousman and seconded by Commissioner Skinner to accept the recommendation of the Planning and Zoning Commission and grant the variance to Utah Power and Light. The motion carried.

Janet Montgomery, Zoning Administrator, presented two bids for cabinets for the Zoning Office. Bids were received from Custom Construction and Mike Grove. It was moved by Commissioner Skinner and seconded by Commissioner Bousman to accept the bid from Mike Grove in the amount of \$729. The motion carried.

Mike McGinnis suggested that the Board consider reconstructing two 1/4 mile peices of the Horse Creek Road, if prices for materials were affordable.

Sealed bids for the ambulance barn were opened and read. Bids were received from Barton Construction, commercial Building Systems, Custom Construction, Higgins Construction, Inc., J & W Construction Company, Inc., Major's Equipment, Mid-Valley General Contractors, Russell Construction Company, Sun & Wind Construction, Inc., Trefren bidder was Wadman Construction. Award of the bid was tabled until the next regular meeting on June 16th.
