





OFFICIAL COUNTY COMMISSIONER PROCEEDINGS JUNE 8, 1987

The Board of County Commissioners met in special session on this date at 11:00 a.m. with Louie Tomassi, Floyd Bousman, Monte Skinner, Janet Montgomery, Dave Harper, Ernie Nunn, Doyle Conklin, Chuck Jones, and Mary Lankford, County Clerk present.

Doyle Conklin, representing the Bridger-Teton National Forest, presented the final agreement for the New Fork Lake Road Project and the Master Road Agreement for consideration. He informed the Board that the final agreement for the New Fork Lake Road needed to be accepted to encumber the Forest Service funds for the provide coop services in cases of emergencies. Commissioner Tomassi informed the Forest Service personnel that Sublette County will not participate in construction of the road beyond the Forest Service fence and that the road will receive summer maintenance only after construction.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to accept the final agreement for the New Fork Lake Road and the Master Road Agreement. The motion carried.

OFFICIAL COUNTY COMMISSIONER PROCEEDINGS JUNE 16, 1987

The Board of County Commissioners met in regular session on this date at 9 a.m. with Louie Tomassi, Floyd Bousman, Monte Skinner, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preeceding regular meeting of June 2, 1987, and a special meeting of June 8, 1987 were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Skinner. Motion carried.

Sealed bids for the construction of a cell at the Pinedale Landfill were opened and read. Bids were received form Mike Looney, Skyline Construction, and Schmid Oilfield Service. It was moved by Commissioner Bousman and seconded by Commissioner Skinner to award the bid in the amount of \$16,000, at the amount of \$.80 per cubic yard. The motion carried.

Sealed bids for the construction of 1.3 miles of fence along the New Fork Lake Road were opened and read. Bids were received from Binning Construction and Schmid Oilfield Service. Bids were rejected from Black Horse Fencing, Solon Murdock, Mack-a-Doo Well Service, Eiden Construction, and Linnco Corporation due to lack of bond accompanying the bid. It was moved by Commissioner Skinner and seconded by Commissioner Bousman to reject all bids. The motion carried. Mike McGinnis, Road & Bridge Foreman, recommended rejecting the bids and postpone the fence construction until the road is constructed.

Jan Lovett and Duane Brant, representing the Learning Center, discussed their budget request and were informed that Social Service agencies will not be funded unless there is unanticipated revenue. Lovett requested consideration from the Board for a building location and possible tax exemption on land donated by Sulentas to the agency. Lovett was referred to John Crow.

A sealed bid form Delgado Oil Company was opened and read to furnish fuel to the County for Fiscal year 1988. It was moved by Bousman and seconded by Commissioner Skinner to accept the bid. The motion carried.

Sealed bids for the custodian services for the Courthouse and Law Enforcement building were opened and read. Bids were received from Grossman Janitorial Services, Half Moon Lodge, Denise Brown, and Mr. & Mrs. Hower. It was moved by Commissioner Skinner and
