

6. Variance application by Mararet McCarty to locate a mobile home on 3 acres zoned A-1 being part of the SE1/4SE1/4, Section 23 and NE1/4NE1/4, Section 26, T33n, R109W. Said Property is approximately 4 miles south of Pinedale on U.S. 191. It was moved by Commissioner Bousman and seconded by Commissioner Skinner to table the application until a representative could be present to represent the application. The motion carried.

The Board met with the New Fork Lake Homeowners concerning the proposed placement of the road. Ken Cameron informed the Board that he was selected to serve as the spokesman for the homeowners. Janet Montgomery described the various possible routes considered on an overhead map. Commissioner Bousman informed the group of the discovery of the existing County Road No. 9 which has been in existence since 1923 which originates near the Bar Cross Ranch and goes north eventually ending at the Forest Service, but the County records of this road are missing. Hicks commented that the location of the existing road was the best solution, due to cost and impact. DeLon Potter of the BLM, stated that the Mocassin Trail route would have the greatest feasibility as a solution to the problem and have the least impact on the homeowners. Cameron stated that the homeowners would adamantly oppose routing the road through the homesites and that the majority of the homeowners preferred leaving the road in its existing location. Excessive cost, environmental effect, economic impact, and close proximity to the homesites were stated as justification of the homeowners' position. John Crow, County Attorney, advised the group that use of the existing road was not feasible, as Noble would take legal action if that route was used. Dave Harper of the BLM, requested to know what provision there was for lost or destroyed records. Cameron stated that the agreement between the County and the Nobles was invalid. The Board informed the group that one of the routes near the homesites would be used and suggested that the session recess for the homeowners to select their preferred route. After a recess, Cameron informed the Board that the homeowners would not protest the proposed Mocassin Trail route. Commissioner Skinner informed the group that when the road is complete, it will only receive seasonal maintenance. Montgomery was directed to notify the homeowners after the Board meets with Noble concerning the new route.

Jordan Rosen reported that Sublette Community Counseling Service will have new hours to be published in the paper. Three days will be in Pinedale and two days in Big Piney. The service is currently servicing 58 clients.
