OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS DECEMBER 1, 1987

The Board of County Commissioners met in regular session on this date at 9 a.m. with Louie Tomassi, Floyd Bousman, Monte Skinner, Mike McGinnis, Ric Samulski, Todd Adams, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of November 17, 1987, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Skinner. The motion carried.

The official bonds for Rod S. Bennett, Sublette County School District #9 Treasurer, in the amount of \$10,000 was approved and ordered filed with the County Treasurer.

Ellen Toth, Director of the Sublette County Retirement Center, presented a corrective deed for acceptance. It was moved by Commissioner Bousman and seconded by Commissioner Skinner to approve and sign the deed. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to adopt Resolution No. 87-160T stating that Sublette County will construct and maintain an access driveway on Highway 352 for the right of way to the Cora Cemetery and private grounds. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to enter into a contract with the State of Wyoming to purchase the Daniel Shop Site for \$100,000 to be paid at a rate of \$10,000 per year for 10 years, interest free, with the first payment due on January 1, 1988, and on the same date every year thereafter. The motion carried. The County Will take possession of the property on January 1, 1988.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to appoint Mary Ellen Painovich and Rollie Myers to the Sublette County Recreation Board for four year
