

half of the \$7,000 required for the construction. Hohl inquired if the County would be able to provide the matching funds. The Board encouraged Hohl to discuss the construction with the local snowmobile clubs and return to the Board.

Willis McAmis informed the Board that construction of the ambulance barn is complete and requested that the completion be advertised.

Bob Maxam, representing the Wyoming Highway Department, presented the final Engineer's recommendations on the New Fork Lake Road for signature and an agreement for funds for a preliminary survey on the Fremont Lake Road.

The Board discussed with Rick Miller, of White Pine Lodge, the status of the ski area. Miller presented the Board a letter from Richard Oglesby advising the Board that Miller has purchased White Pine Lodge. The cooperative agreement between Miller, the Forest Service, and the County for snow plowing was discussed. Miller informed the Board that he had contracted for snow removal equipment and if the agreement was not signed, he would do the work himself. Commissioner Bousman expressed his concern for the use of the area by cross country skiers and snowmobilers currently using the area. Commissioner Bousman requested two amendments to the agreement being annual review and renewal and change in wording placing the plowing burden on White Pine and not on the County. It was agreed to amend the agreement. The Board signed the agreement as amended. Mike McGinnis expressed concern for the signing of the road during plowing. Miller stated the road would be signed.

Paul Scherbel, County Surveyor, was directed to prepare the legal description for the Granite Creek Road.

It was moved by Commissioner Bousman and seconded by Commissioner Tomassi to adopt Resolution No. 88-163T concerning disbursing \$12,000 to the Joint Big Piney-Marbleton Volunteer Fire Department Board from the general fund. The motion carried.
