

The Board of County Commissioners met in regular session this date at 9 a.m. with Louie Tomassi, Floyd Bousman, Monte Skinner, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of April 5, 1988, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Skinner. The motion carried.

The official bond for Paul N. Scherbel, County Surveyor, in the amount of \$1,000 was approved and ordered filed with the County Clerk.

Sealed bids for a six-wheel drive, articulated motor grader for the Road and Bridge Department were opened and read by Commissioner Tomassi. Bids were received from Wyoming Machinery Company and S & S Machinery. The bid was awarded to S & S Machinery for the amount of \$79,950 on motion by Commissioner Bousman and seconded by Commissioner Skinner. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to award the bid on a four-wheel drive backhoe to S & S Machinery in the amount of \$47,000. The motion carried.

Carl Ingersoll presented a letter on behalf of the Tri-County Group Home regarding consideration for funding. The action was taken.

Annie Weber, Public Health Nurse, discussed the purchase of a computer for her office.

The applications for the County Commissioners Tuition Waiver Scholarships were reviewed. Two scholarships were awarded to Pinedale High School seniors Tomi Sue Bousman and Nikol Vickrey, with Eric Schooley, first alternate and Tay Lozier, second alternate. One scholarship was awarded to Big Piney High School senior Kenna Tanner, with Rebecca Copeland as alternate. The renewal scholarship was awarded to Patricia Jensen.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to purchase tail insurance for 12 months for the law enforcement and public officials liability policies. The motion carried.

Rusty Gooch and Gary Bingham of the Pinedale Area Chamber of Commerce, presented a letter supporting the purchase of the old elementary school, but strongly objecting to the rental of office space.

In accordance with the agenda published in the Pinedale Roundup on March 31, 1988, public hearing was held for the following:

1. Commissioner Skinner moved that the Board accept and act upon the recommendation of the Planning and Zoning Commission. Commissioner Bousman seconded the motion. Upon vote, the motion carried and the following resolution was adopted.

RESOLUTION NO. 88-173T

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION BY MARK WHITE TO RECLASSIFY AND REZONE 5 ACRES, MORE OR LESS, FROM A-1 DISTRICT TO I-L DISTRICT BEING THAT PART OF THE NW1/4NW1/4SW1/4, SECTION 34 LYING EASTERLY OF COUNTY ROAD NO. 23-177 AND ALL OF THE W1/2NE1/4NW1/4SW1/4 OF SAID SECTION 34, T31N, R111W, SUBLETTE COUNTY, WYOMING.

2. It was moved by Commissioner Skinner and seconded by Commissioner Bousman to deny to application by Miles Hopkins for a variance to locate a manufactured home on Lot 17 of Pine Creek Subdivision. The motion carried. The reason for the denial of the application was that the economic hardship presented was not a valid reason to grant the variance in accordance with the County Zoning Regulations.

The Board approved the establishment of free dump days at the County Landfills with dates to be coordinated with the Towns.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to adopt Resolution No. 88-174T concerning the increase of the speed limit on Fayette Pole Creek County Road No. 23-121 to 40 miles per hour. The motion carried.

Minnie Bollinger appeared before the Board and was referred to the County Attorney.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to adopt Resolution No. 88-171T concerning the vacation of streets and alleys included in the Townsite of Daniel plat and the substitution of Daniel Third Plat. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to release the road bond for Happy Trails Subdivision. The motion carried.

Kim Linn, representing the Community Food Closet, Inc., discussed her proposed application for Community Service Block Grant funds.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to adopt Resolution No. 88-170T concerning the charging for copies of information from the Local Emergency Planning Committee. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to upgrade the existing computer system to include the Clerk of District Court and Sheriff's Department. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to adopt Resolution No. 88-172T authorizing an application for a Mineral Royalty Grant for the replacement of the bridge over the New Fork River on Paradise County Road No. 23-136. The motion carried.
