## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS MAY 17, 1988

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Floyd Bousman, Monte Skinner, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of May 3, 1988, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Skinner. The motion carried.

The official bonds for Harry Krininger, Landfill Operator, in the amount of \$1,000 and William J. Backs, Treasurer for the Hoback Ranches Service and Improvement District, in the amount of \$5,000 was approved and ordered filed with the appropriate office.

Bob Maxam, Project Engineer for the Wyoming Highway Department, discussed the bid letting scheduled for June 16 for the New Fork Lake Road with completion scheduled for September 30, 1988. Minor fencing changes were approved. State funding for the project was discussed.

Janet Montgomery, Zoning Administrator, reported that the BLM has appraised the 80 acres at the Marbleton Landfill at \$1600 and discussed the bidding process on the purchase of the property.

The Andrew Amended Lot Division Plat was approved and signed.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to allow an exemption of the County Lot Division Regulations for a minor boundary adjustment to George L. Grassell, Jr. for Tract 5, Looney First Subdivision. The motion carried.

Mary Spence discussed the Daniel Second Plat with the Board and expressed her concerns about the project being a subdivision.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to approve a malt beverage permit for June 11 and 12, 1988, issued to the Sublette County Outfitters and Guides Association for the 2nd Annual Pack Horse Race. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to approve a tax reduction order for Utah Power & Light Company in the amount of \$6,962.58. The motion carried.

Scott Albright requested that the County abandon the Cora Bronx Road which is included in his property near Cora. It was moved by Commissioner Bousman and seconded by Commissioner Skinner to proceed with the abandonment procedures. The motion carried.

In accordance with public notice published in the Pinedale Roundup on April 21, 28, May 5, and 12, 1988, public hearing was held for the transfer and renewal of County Retail Liquor Licenses, Restaurant Liquor Licenses, and Retail Malt Beverage Permits.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to approve the
