It was moved by Commissioner Bousman and seconded by Commissioner Skinner to approve the renewal applications for Retail Malt Beverage Permits for Boulder Lake Lodge, Hoback Villiage, The Place (transfer and renewal), Green River Guest Ranch, Lakeside Lodge, Rim Station (transfer and renewal), Dane's Chevron Country Store (transfer and renewal), and Triangle F Lodge. The motion carried.

It was moved by Commisioner Bousman and seconded by Commissioner Skinner to approve the renewal application for a Special Club License for the Pinedale Golf Club, Inc. The motion carried.

It accordance with the public notice published in the Pinedale Roundup on April 21, 28, May 5, and 12, 1988, public hearing was held for the issuance of a Retail Liquor License. Applications were received from the Green River Guest Ranch, Hoback Village, Lakeside Lodge, and The Place. It was moved by Commissioner Skinner and seconded by Commissioner Bousman to issue the retail liquor license to The Place. The motion carried. Pete Steele questioned if the license could be issued due to the reduction of population. Lyle Pendergast and Ken Myers expressed their feeling that the license should bring additional revenue to the County. Betty Lou McLoughlin, owner of The Place, indicated that she had not built cabins due to competing with Lyle Pendergast. Roy Fisk stated that he felt that the recipient should be drawn due to the number of applicants.

Representatives of the Board of Directors of the Sublette Community Counseling Service discussed the program's progress over the past year. Ed DeLong presented statistics on services provided and stated that another clinician is needed. Letters of support were presented and possible funding was discussed.
