

## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

MAY 24, 1988

The Board of County Commissioner met as the Board of Equalization on this date at 9:00 a.m. with Louie Tomassi, Floyd Bousman, Monte Skinner, Hazel Werner, County Assessor, and Mary Lankford, County Clerk present.

Since no one was present to appear before the Board of Equalization, the Board recessed and sat as the Board of County Commissioners.

In accordance with the notice published in the Pinedale Roundup on May 19, 1988, public hearing was held for the transfer of funds in the amount of \$16,000 from Cash Reserve to County Attorney in the amount of \$10,000 and Clerk of District Court in the amount of \$6,000. There being no objections, it was moved by Commissioner Bousman and seconded by Commissioner Skinner to adopt Resolution No. 88-177T authorizing transfer of County budget funds. The motion carried.

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS JUNE 7, 1988

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Floyd Bousman, Monte Skinner, Mike McGinnis, Todd Adams, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of May 17, 1988, and Board of Equalization meeting of May 24, 1988, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Skinner. The motion carried.

In accordance with the public notice published in the Pinedale Roundup on June 2, 1988, public hearing was held for the transfer of funds in the amount of \$20,265 from the General Fund to County Law Enforcement. There being no objections, it was moved by Commissioner Skinner and seconded by Commissioner Bousman to adopt Resolution No. 88-178T authorizing transfer of County budget funds. The motion carried.

The official bonds for Alice Griggs, Clerk/Treasurer of the Town of Marbleton, in the amount of \$50,000, and Peter Arambel, Secretary/Treasurer of the Sublette County Predatory Board, in the amount of \$1,000, were approved and ordered filed with the County Treasurer.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to approve a malt beverage permit for June 11, 1988, issued to the Boulder Community Center for an "Evening of Fun". The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to appoint Paul Scherbel as viewer for the New Fork River Bridge project on Paradise County Road No.-23-136. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to appoint the following election judges and alternates, counting board, and canvassing board for a term of two years:
