OFFICIAL COUNTY COMMISSIONER PROCEEDINGS JULY 19, 1988

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Floyd Bousman, Monte Skinner, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of July 5, 1988, were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Bousman. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to authorize the purchase of a fire truck for the Boulder Fire Department. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to sign the Budget resolution approved the previous evening. The motion carried.

The official bonds for Rex Poulson, Treasurer of the Library Board, in the amount of \$4,000, and Gary Espenscheid, Treasurer of the Fiar Board, in the amount of \$2,000, were approved and ordered filed with the County Treasurer.

The Board requested the County Clerk to notify the Department Heads and Elected Officials regarding their concerns about the FY 89 budget and proposed revenues.

It was moved by Commissioner Skinner and seconded by Commissioner Bousman to rescind their motion of July 5, 1988, concerning the County fuel bid, and award the bulk regular and unleaded gasoline and key pump bid to Delgado Oil Company, and the bulk diesel fuel bid to Fremont Chemical. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to approve malt beverage permits for August 12 and 13, 1988, issued to the Big Piney Lions Club for the concession at the Little Britches Rodeo. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Skinner to approve malt beverage permits for August 13 and 14, 1988, issued to the Knights of Columbus for the concession at the softball tournament during the County Fair. The motion carried.

Don Wright of the Big Sandy Ranch, discussed with the Board the possibility of moving the County Road on the ranch property. Wright informed the Board that the owner would bear the cost of construction and rehabilitation. The County Clerk was directed to notify the BLM concerning the moving of the road.

Bucky and Lucy Neely and Mary Channell requested that condemnation procedures be started to obtain right of way to a tract of land owned by Mary Channell. Vernon Mrak, Gordon Johnston, and Stuart McKinley were appointed as viewers and will be contacted by John Crow to proceed.

After discussing the drought situation in the County with Dan Budd and Eric Peterson, it was moved by Commissioner Bousman and seconded by Commissioner Tomassi to adopt Resolution No. 88-184T declaring Sublette County a drought disaster area. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Tomassi to approve the mill levy requests for the Sublette County Mosquito Abatement District No. 1 and the Sublette County Preditory Animal Control Board. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Tomassi to accept the viewers report on the New Fork River bridge on Paradise County Road No. 23-136 and the appropriate resolution. The motion carried.

It was moved by Commissioner Bousman and seconded by Commissioner Tomassi to allow the County Treasurer to discharge the uncollectible debt presented in accordance with Section 16-4-502, Wyoming Statutes, 1977, as amended. The motion carried.
