A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION BY SCOTT ALBRIGHT TO RECLASSIFY AND REZONE 40.62 ACRES, MORE OR LESS, FROM R-R DISTRICT TO A-1 DISTRICT BEING PART OF SECTION 4, T34N, R110W, SUBLLETTE COUNTY, WYOMING.

## OFFICIAL COUNTY COMMISSIONER PROCEEDINGS AUGUST 2, 1988

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Floyd Bousman, Monte Skinner, Mike McGinnis, Todd Adams, and Mary Lankford, County Clerk present.

The minutes of the preceding budget hearing of July 18, 1988, and the regular meeting of July 19, 1988, were approved and ordered filed on motion by Commissioner Bousman and seconded by Commissioner Skinner. The motion carried.

The official bond for Paul N. Scherbel, Treasurer of the Joint Big Piney-Marbleton Volunteer Fire Department Board, in the amount of \$20,000, was approved and ordered filed with the County Treasurer.

Annie Weber, Public Health Nurse, informed the Board that State of Wyoming long-term employees were granted a \$550 bonus and 5% increase in salary for FY89. It was moved by Commissioner Skinner and seconded by Commissioner Bousman to endorse the increase, amounting to approximately \$2500, to be transferred to the budget when needed. The motion carried.

The mill levy request by Hoback Ranches Improvement District was approved.
