


COUNTY COMMISSIONER PROCEEDINGS NOVEMBER 15, 1988

The Board of County Commissioner met in regular session on this date at 9:a.m. with Louie Tomassi, Monte Skinner, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of November 1, 1988, were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Tomassi. The motion carried.

Annie Weber, Public Health Nurse, informed the Board that the State is proposing an increase in the County's percentage of participation in next year's budget. The County would receive all revenues collected by the local program.

Burleigh Binning expressed his concerns regarding the use of County equipment in competition with private enterprise. Commissioner Skinner informed Binning that the Forest Service was responsible for the dispatching of County equipment on this summer's fires and that the County's equipment was available on an emergency basis only.

It was moved by Commissioner Skinner and seconded by Commissioner Tomassi to adopt a policy requiring written permission from private land owners before plowing snow catchers on provate property. The permission will remove the responsibility for damages from the County. The County Attorney will prepare the proper documents.

The following petitions and affidavits for abatements of taxes were presented on petition from the State Board of Equalization: Chevron U.S.A., Incorporated, \$3,382.55; Mobil Oil Corporation, \$285.75, \$1,167.86, and \$3.02.

Bob Looney presented a slide presentation on the War Memorials that exist in surrounding counties. Looney requested the Board's endorsement and commitment of funds to construct a war memorial in front of the Courthouse to honor people who served during World Wars I and II, Korea, and Viet Nam to serve as a Centennial project for the County. A decision was tabled until the committee is formed and project costs can be determined.
