OFFICIAL COUNTY COMMISSIONER PROCEEDINGS MARCH 7, 1989

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Monte Skinner, Craig Crandall, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of February 21, 1989, were approved and ordered filed on motion by commissioner Skinner and seconded by Commissioner Crandall. The motion carried.

The official bond for Bonnie Krininger, Landfill Attendant, in the amount of \$1,000, was approved and ordered filed with the County Clerk.

In accordance with the public notice published in the Pinedale Roundup on March 2, 1989, public hearing was held for the transfer of funds in the amount of \$26,386 from Unanticipated Revenue to Assessor-Reappraisal, \$25,886; and General Fund-Historic Survey, \$500. There being no objections, it was moved by Commissioner Crandall and seconded by Commissioner Skinner to adopt Resolution No. 89-203T authorizing transfer of County budget funds. The motion carried.

Rex Poulson, Barbara McKinley, and Sally Swift, representing the Library Board, discussed the construction of an addition onto the Big Piney Library. Funding for the project will be obtained from a federal grant which will require a 60% local match of funds. It is estimated that the local match will be approximately \$36,000. The Board endorsed the project and informed them that the money will be budgeted.

Dana Stone, State Forest Ranger, presented the 1989 Wildland Fire Control Annual Operating Plan for Sublette County. The Board endorsed the plan. The past summer's fires were discussed.

The following petition and affidavit for abatement of taxes was presented on petition from the State Board of Equalization: AT&T Communications, \$584.47.

In accordance with the agenda published in the Pinedale Roundup on March 2, 1989, public hearing was held for the following:

It was moved by Commissioner Skinner and seconded by Commissioner Crandall to accept and act upon the recommendation of the Planning and Zoning Commission and approve the conditional use permit request by Harvey Stone to store oil well drilling equipment on his property zoned A-1 located in the NW<sup>1</sup>/SW<sup>1</sup>, Section 23 T35N, R111W, Sublette County, Wyoming. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Crandall to adopt Resolution no. 89-204T to initiate the procedure to vacate a portion of Scab Creek County Road No. 23-122. The motion carried.

The application for a right of way from the BLM for the Fremont Lake County Road No. 23-154 was signed.

The Boulder Cemetery Enlargement Plat was signed.
