




OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS OCTOBER 3, 1989

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Monte Skinner, Craig Crandall, Mike McGinnis, John Crow, Dave Arambel of the Pinedale Roundup, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of September 5, 1989, were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Crandall. The motion carried.

In accordance with the public notice published in the Pinedale Roundup on September 28, 1989, public hearing was held for the transfer of funds in the amount of \$1,000 from the General Fund to the County Health, Rent-Health Offices budget. There being no objections, it was moved by Commissioner Crandall to adopt Resolution No. 89-225T authorizing the transfer of County budget funds. The motion carried.
