## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS OCTOBER 17, 1989

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Monte Skinner, Craig Crandall, Mike McGinnis, Dave Arambel of the Pinedale Roundup, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of October 3, 1989, were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Crandall. The motion carried.
