


OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS JANUARY 2, 1990

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Monte Skinner, Craig Crandall, Dave Arambel of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of December 19, 1989, were approved and ordered filed on motion by Commissioner Crandall and seconded by Commissioner Skinner. The motion carried.

Paul Rock, editor of the Pinedale Roundup, discussed his difficulty in obtaining the police report from the Sheriff's Office and was referred to John Crow.

It was decided to schedule a public meeting to discuss the current location and possible relocation of the Whelan Bridge, on Tuesday, January 16, 1990, at 7:30 p.m. at the Marbleton Fire Hall.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to declare the running at large of dogs in unincorporated areas within the county limits a public nuisance, in accordance with W.S. 11-31-301. The motion carried. Deputy County Attorney Van Graham was directed to make the proper notification.

Macille Carr and Jill Tegeler of the Sublette County Centennial Committee, discussed fund raising and the Lasting Legacy Grant received for parks improvements in Big Piney. There will be a county booth in Cheyenne in July. The Board endorsed \$3,000 in matching funds for the Lasting Legacy Projects and referred the Committee to the Recreation Board for the funding request, for the FY91 budget.

Bob Looney and Ken Shriver of the Sublette County Weed and Pest Board, requested the transfer of a two-wheel drive pickup from the Road and Bridge Department. It was agreed to transfer the pickup when the new pickups arrive.

The following petition and affidavit for abatement of taxes was presented on petition from the State Board of Equalization: McGarvin Moberly Construction Company, \$2,055.06; and Maxus Energy Corporation, \$15,131.51.

Penny Chrisman was appointed to a five year term to the Sublette County Fair Board. No appointment was made to the Pinedale Airport Board, as there were no volunteers.
