

study relative to the marketing and promotion of southwestern Wyoming. There being no objections, the Board endorsed the application and will sponsor the application.

Loren Smith, Water Commissioner, discussed the telephone at the Fair Grounds and was assured that the telephone will not be changed, even though the cost for service will double.

Paul Scherbel, County Surveyor, presented all the materials for the application for an Industrial Road grant, in the amount of \$200,000, a Farm Loan Board grant, in the amount of \$240,000, and appropriate information for the Wyoming Highway Department for the Whelan Bridge project. The estimated cost of the project is \$480,000 for a single lane bridge. Sublette and Lincoln Counties will each provide approximately \$20,000 for the project.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to designate the First National Bank of Pinedale as a Sublette County depository. The motion carried.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to appoint Mack Rawhouser to the Recreation Board. The motion carried.

In accordance with the public notice published in the Pinedale Roundup on February 1, 1990, public hearing was held for the following:

1. It was moved by Commissioner Crandall and seconded by Commissioner Skinner to accept and act upon the recommendation of the Planning and Zoning Commission. Upon vote, the motion carried and the following resolution was adopted:

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION BY THE SUBLINTE COUNTY PLANNING AND ZONING COMMISSION TO RECLASSIFY AND REZONE 20 ACRES, MORE OR LESS, FROM A-1 TO RM DISTRICT, BEING LOTS 1 AND 3, HECOX HEAVEN SUBDIVISION.

2. It was moved by Commissioner Crandall and seconded by Commissioner Skinner to approve the application by John M. Sulenta to allow a 234 foot right-of-way width for access to property in Section 8, T34N, R108W. The motion carried.

3. It was moved by Commissioner Skinner and seconded by Commissioner Tomassi to approve the application by Craig Crandall to allow a 20 foot setback from Highway 191 right of way in Section 10, T33N, R109W. The vote was Skinner-aye, Tomassi-aye, and Crandall-abstained.

4. It was moved by Commissioner Crandall and seconded by Commissioner Skinner to issue a permit to Grindstone Cattle Company for a ranch sign at the junction of DeSmet County Road No. 23-188 and Price Todd County Road No. 23-187. The motion carried.

5. It was moved by Commissioner Crandall and seconded by Commissioner Skinner to issue a 5 year extension to William H. Smith and Associates for an existing dormitory on Lot 3, Gopher Ridge Industrial Park. The motion carried.

The following petition and affidavit for abatement of taxes was presented on petition from the State Board of Equalization: Enron Oil and Gas Company, \$2,008.82.

The Board directed that a letter be drafted to the Public Health Nurse concerning providing flue shots.
