OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS MARCH 6, 1990

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Monte Skinner, Craig Crandall, Dave Arambel of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of February 20, 1990, were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Crandall. The motion carried.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to sign the cost sharing agreement with Lincoln County for the Whelan Bridge project. The motion carried.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to not participate in the Fire Emergency Suppression Account. The motion carried.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to approve a malt beverage permit for March 24, 1990, to be issued to the Daniel Homemakers for the Aniel Daniel Chili Cookoff. The motion carried.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to adopt Resolution No. 90-239T for the purpose of accepting a warranty deed from Joel Dustin and Elizabeth S. Dustin, husband and wife, for a tract of land in Lot 3, Section 2, T33N, R11W, Sublette County, Wyoming. The motion carried.

Kevin Coulter and John Blaha discussed the Daniel Volunteer Fire Department building and the Farm Loan grant application. It was decided that John Blaha would be the designated negotiator for the County for the Annual Operating Plan which is provided by the State Forester.

Tom Delgado, Pinedale Mayor, and Bob Harrower of Rio Verde Engineering presented the cost projections for the Pinedale Area Sewer and Water Improvement project. It was moved by Commissioner Crandall and seconded by Commissioner Skinner to endorse the project and the County's share of \$121,000 for a Farm Loan Board Grant application. The motion carried.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to adjourn the meeting and hold a work session. The motion carried.
