OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS MAY 1, 1990

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Monte Skinner, Craig Crandall, Dave Arambel of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of April 17, 1990, were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Crandall. The motion carried.

The official bond for Paul Scherbel, County Surbeyor, in the amount of \$1,000 was approved and ordered filed with the County Clerk.

Vance Brewer and Ron Jackson of Liggett Industries, Inc., presented information on industrial lubricants and educational and maintenance programs for their use. Jackson and Brewer were referred to Mike McGinnis for a recommendation to the Board.

Larry Konetzski, Craig Jackson, and Bob Maxam of the Wyoming Highway Department, discussed the Whelan Bridge project and signed the project agreement for \$500,000. The road will end at the end of the 26 foot bridge with a 24 foot road width. Inverted pen will be used on the approach to the bridge and for a short distance beyond the bridge. The cattleguard will be the Highway Department's responsibility.

It was moved by Commissioner Crandall and seconed by Commissioner Skinner to approve and sign an easement from Sublette County to Carl and Peggy Winters from the golf course road to their property west of the golf course. The motion carried.

The application for the County Commissioners' Tuition Waiver Scholarship were reviewed. Two scholarships were awarded to Pinedale seniors Cody Saxton, with Terry Moss an alternate, and Wes Allen, with Travis Pfaff as alternate. One scholarship was awarded to Big Piney senior Gary Burnett, with Tim Sorensen as alternate. The renewal scholarship was awarded to Meredith Price, with Taylene Lozier as alternate.

Mike McGinnis discussed various Road & Bridge matters with the Board.
