

hearing. John Mackey read a letter from Joella Dugan concerning the erection of a sign indicating the Binning Ranch Road for emergency services. Gerald Mason, representing Stan Murdock, requested the naming of the road which accesses the Murdock ranch be named the Murdock Ranch Road and the road which provides access to the small tracts adjacent to the Murdock property be named Murdock Mesa Road, for the purpose of rural addressing and emergency services. It was moved by Commissioner Crandall and seconded by Commissioner Skinner to name the roads as requested by Murdock and will refer Mrs. Dugan to Murdock to discuss the erection of the Binning Ranch Road sign. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Crandall to adopt Resolution No. 90-251T which incites the procedures for vacating County Road No. 20 in accordance with W.S. Section 24-3-110, as amended, which was replaced by U.S. Highway 189. the motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Crandall to issue a permit to Telephone Utilities of Wyoming to reinforce existing buried telephone cable under Muddy Creek County Road No. 23-177. The motion carried.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to issue a permit to Telephone Utilities of Wyoming for an underground telephone line under Roberts County Road No. 23-157. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Crandall to issue a permit to Western Geophysical Company to cross County Road Nos. 23-198, 23-134, 23-111, and 23-153 with seismograph lines. The motion carried.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to sign an agreement with the Retirement Center of Sublette County, Inc., for an easement over and across the grounds of the Retirement Center to provide a cross-country ski course. The motion carried.

Janet Montgomery, Zoning Administrator, reported that Peter Flanigan had received a right of way from the BLM.

Ron Galloway of Olivine Incineration System presented a video on municipal waste incineration.

It was moved by Commissioner Skinner and seconded by Commissioner Crandall to designate May 27, July 1, and September 2, 1990, as days for unrestricted operation by Liquor licensees in the County in accordance with Section 12-5-101(c), Wyoming Statutes, 1977, as amended. The motion carried.

After discussion, it was decided to bid another cell at the Marbleton Landfill and arrange a meeting with the DEQ and Teton County.

The Board preliminarily approved a 3% cost-of-living increase for County employees for FY91.
