## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS MAY 15, 1990

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Monte Skinner, Craig Crandall, Dave Arambel of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of May 1, 1990, were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Crandall. The motion carried.

The official bonds for Patty Racich, Town of Pinedale Clerk/Treasurer, in the amount of \$50,000; Betty Lou McLoughlin, Treasurer of the Upper Green River Cemetery District, in the amount of \$1,000; and Penny Chrisman, Treasurer of the Sublette County Fair Board, in the amount of \$2,000 were approved and ordered filed with the County Treasurer.

Ed Wood, representing Froerer Corporation, inquired about property in the Green River Ranches Subdivision which had been acquired by Sublette County due to unpaid taxes. It was moved by Commissioner Skinner and seconded by Commissioner Crandall to obtain a listing of all property acquired by the County due to unpaid taxes and conduct an auction of such property. The motion carried.

Sandy Brewer and Sonny Korfanta of the Sublette Hi-Country Senior Citizens, Inc., discussed an addition onto their building. The Board requested an estimate and suggested a full garage to house their bus. Grant funds will be researched.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to issue six beer permits to the Sublette County Sporting Association for June 17 and 29, July 6, 7, 8, and September 2, 1990 for the concession at the rodeo grounds. The motion carried.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to designate the Key Bank of Wyoming, Big Piney as a depository for County funds. The motion carried.

In accordance with the public notice published in the Pinedale Roundup on April 26, 1990, public hearing was held for the following:
