

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Monte Skinner, Craig Crandall, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of June 19, 1990, were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Crandall. The motion carried.

Sealed bids for the sale of used cattleguards and culverts from the Road and Bridge Department, Southern Division, were opened and read. It was moved by Commissioner Skinner and seconded by Commissioner Crandall to award the following bids:

The motion carried.

The official bond for Sharon A. Wagstaff, Landfill Attendant, in the amount of \$1,000, was approved and ordered filed with the County Clerk.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to issue a malt beverage permit to the Daniel Do More Club for July 13, 1990, at the Daniel Schoolhouse for a Centennial Dance. The motion carried.

After discussion about the recent fire near Hoback Ranches, it was moved by Commissioner Crandall and seconded by Commissioner Skinner to allow the County Fire Warden to make expenditures up to \$25,000 without Commissioners' approval and require approval for any amounts over \$25,000. The motion carried.

Bill Backs and Norman Larsen of Hoback Ranches discussed their roads and the cost of weed spraying. Backs and Larsen were referred to the Weed and Pest Board and its director.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to adopt Resolution No. 90-261T authorizing the transfer of \$27,088.10 from the General Fund to the following accounts: County Clerk, \$1,900.00; Justice of the Peace-Cramer, \$1,500.00; Justice of the Peace-Ball, \$750.00; Detention & Communications, \$18,500.00; and CPA Audit, \$4,438.10. The motion carried.

Sonny Korfanta and Horace Swain discussed their concern about trail closures by the Forest Service. The Board decided to schedule a public hearing for July 16, 1990, at 6 p.m. for public input. The County Clerk was directed to make the proper notification.

The budget for the Upper Green River Cemetery District of \$60,585.27 was tentatively approved.

Kathy Raper informed the Board that she is working to establish a recycling center in Pinedale and requested use of the elementary school cafeteria building. Raper will develop a formal proposal and return for consideration.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to approve the mill levy request from the Hoback Ranches Service and Improvement District of 8 mills and the Sublette County Preditory Animal Control Board of 2 mills for cattle and 35 mills for sheep. The motion carried.

Upon request by Fred G. Petersen, it was moved by Commissioner Crandall and seconded by Commissioner Skinner to grant Petersen an exemption to the lot division regulation for Lot 1, 5th Filing of Boulder Lake Country Estates. The motion carried.

Upon request by Doyle Child, it was moved by Commissioner Crandall and seconded by Commissioner Tomassi to grant Child an exemption to the lot division regulation for Tract 9, Sheet 6, Hoback Ranches. The motion carried.

In accordance with the public notice published in the Pinedale Roundup on June 28, 1990, public hearing was held for the following:

1. It was moved by Commissioner Crandall and seconded by Commissioner Skinner to accept and act upon the recommendation of the Planning and Zoning Commission. Upon vote, the motion carried and the following resolution was adopted:

3. It was moved by Commissioner Crandall and seconded by Commissioner Skinner to grant a variance to William H. and Janet F. Doering to allow a variance of the side setback for Lot 47, Boulder Lake Country Estates, Second Filing. The motion carried.
