

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS SEPTEMBER 4, 1990

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Louie Tomassi, Monte Skinner, Criag Crandall, Dave Arambel of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of August 22, 1990, were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Crandall. The motion carried.

It was moved by Commissioner Skinner to award the bid for the purchase of three dump trucks and one fifth-wheel tractor to Casper Truck Center, Inc. for the total purchase price of \$254,511, at \$73,913 per dump truck and \$32,772, net price, for the fifth-wheel tractor. Commissioner Crandall seconded the motion. The motion carried.

Larry Deats of Wyoming Machinery presented some additional information on his motorgrader bid. It was moved by Commissioner Crandall and seconded by Commissioner Skinner to reject all motorgrader bids due to lack of funds. The motion carried.

A County Road access was awarded to Texaco at Calpet on County Road No. 23-134.

The session recessed until the afternoon at which time Chairman Tomassi was absent and Commissioner Skinner assumed the Chair.

Bubba Larson discussed his tax assessment and was referred to the County Assessor. Larson also discussed a summons he had recently received concerning zoning violations. Van Graham, Deputy Prosecuting and County Attorney, informed Larson that the Board of County Commissioners were unable to resolve the situation and that he is required to present his case to the District Court. Janet Montgomery, Zoning Administrator, informed the Board that Larson has failed to file a zoning and development permit and sewer and water permits for three years, and still has no permitted uses on his property. An apparent salvage yard on the Larson property was discussed.

Ray Bredthauer discussed the zoning on the property located at the corner of U.S. Highway 191 and Ehman Lane. The present zoning specifically denies the establishment of a salvage yard. Bredthauer was referred to the Planning & Zoning Commission.

Bill Twichell, Georgia Costello, and Linda Dickerson, presented a petition to establish Sublette County Mosquito Abatement District No. 2. Public hearing was held for the petition without opposition. It was moved by Commissioner Crandall and seconded by Commissioner Skinner to accept the petition and adopt Resolution No. 90-269T establishing the district and calling an organizational election pursuant to W.S. 18-12-122, on November 6, 1990, to include the election of a Board of Directors consisting of three people. The motion carried.
