

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS NOVEMBER 8, 1990

Bill Cramer requested information on the Upper Hoback Road maintenance.

Gary Wilson requested information regarding the willows adjacent to his property on Ehman Lane.

Permits for utility lines within a County right of way were issued to Utah Power & Light Company on County Road No. 230145 and Telephone Utilities of Wyoming on County Road No. 23-109.

It was moved by Commissioner Crandall and seconded by Commissioner Skinner to contract with Rocky Mountain Auditing for \$10,000 and 5% of all tax recoveries on mineral audits. The motion carried.

Madeline Lunbeck presented a petition to establish the Cora Y Mosquito Abatement District No. 3. Public hearing was held for the petition without opposition. It was moved by Commissioner CRandall and seconded by Commissioner Skinner to accept the petition and adopt Resolution No. 90-277T establishing the district and calling an organizational election pursuant to W.S. 18-12-122, on December 19, 1990, to include the election of a Board of Directors consisting of three people. The motion carried.

School District #9 Superintendent Swight Parrish and SCchool District #1 Superintendant Don Wright with delegations from the respective districts appeared before the Board to discuss the recent tax abatements received by the County. It was moved by Commissioner Crandall and seconded by Commissioner Skinner to repay the abatements over a five(5) year period. The motion carried. County Assessor Hazel Werner informed the group that she is unable to determine a boundary line change at this time. Discussion of the situation was presented by Parrish, Wright, and Gerald Mason, Attorney for School District #1. The maount of tax dollars available per student in each district was debated. It was decided to discuss the situation with the Joint Education Sub-committee and the State Board of Equalization at meetings scheduled within the next two weeks.
